Anne Lally reviewed HUD Grant OH0455L5E041906 – This grant provides 10 vouchers for clients to assist them with rental assistance. This grant will run from 4/1/2020 to 3/31/2021 and the services will be contracted through Help Network as in years past. The award is for \$124,124.00.

 Anne Lally reviewed CIT Grant – The Board applied for Ohio CIT Support and Expansion Project Grant. This grant will provide funding to cover costs of two CIT coordinators as well as allow us to expand the program with Dispatcher and Advanced CIT courses. The award is for \$39.123.77

 Anne Lally reviewed the increase in Community Transition Program -We received notice of an additional \$75,000 in CTP dollars. The goal of this funding is to reduce recidivism and supports the successful recovery and positive long-term outcomes for individuals managing a substance use disorder and/or diagnosed with a severe mental illness as they transition from prison to the community.

52 – 2020: Motion: Marilyn Burns – to accept the Community Transition Program increase of \$75,000. Seconded by: Bill Morvay...motion carried

 Anne Lally and Duane Piccirilli reviewed the request for a resolution to approve acceptance of the Resiliency Grant for Alta at YDC property, and signatures for the documents. This is a capital grant that requires a 30 year contract mortgage, and note be executed between OhioMHAS, Alta and the MCMHRB. This capital grant requires no matching funds.

53 – 2020: Motion: Eric Ungaro – The Mahoning County Mental Health and Recovery Board approves this project with an assurance of intent to support and to fund the Applicant's program consistent with the application and, in addiction, to annually monitor the program and operations of the facility to assure compliance. The MCMHB authorizes Anne Lally, Board Chair, and Duane Piccirilli, Executive Director to execute the contract and other necessary documents to complete acceptance of these funds. #### **Provider Remarks**

Angela DiVito – discussed the Coalition for a Drug Free Mahoning County is currently in grant writing season, so they have been focused on grant applications, and updating training.

Joe Shorokey – stated that YDC project is moving forward, and thanked the Board for their approval of the resiliency grant. Meg Harris will be presenting at the Ohio virtual trauma event with over 1,000 people signed up for her session. Telehealth is working well. The challenge will happen in 3 to 4 months when the lack of current new admissions will be felt.

Carolyn Givens – reported that Neil Kennedy Recovery Centers has been consistently seeing clients either in person or through telehealth based on the level of care.

Larry Moliterno – announced that Meridian Primary Care is reopening for in person services as well as continuing telehealth. Outpatient counseling services are ongoing. Residential services population has been reduced to meet social distancing needs. Those in housing have been struggling with behaviors, case management is working with these clients. Prevention is continuing work with the population virtually as well as working with those in housing. TASC is working with the courts, which are looking to open a bit more on June 1st. Revenue is down, but they have not had to utilize reserves, and are hoping to delay that as long as possible.
