- Community Relations and Marketing Committee (January 11, 2021)
 - o Anne Cobbin reviewed the committee meeting with the Board. The Board and agencies have been looking into hiring a marketing company to help relay our message to the community. Using a Facebook AD account can target specific audiences and tracks the effectiveness of each ad. Instagram targets a crowd of 30 years old and younger and also has an AD account option. The committee discussed updating older agency and Board advertisements as well as updating suicide prevention ads to include at risk audiences such as veterans and the LGBTQ. Lastly, the committee discussed using K-12 funding to help reengage K-12 students who have fallen off track due to Covid-19.

- Joe Caruso, Compass Family and Community Services thanked the Board for providing the agency with adequate PPE for their staff and patients. Compass worked with the Mahoning County Health Department to get their staff and employees Covid-19 vaccinations easily and smoothly. They are looking forward to receiving the second dose of the vaccine.
- Vince Brancaccio, Help Hotline thanked the Board for their assistance during Covid-19 and providing them with more than enough PPE for their staff and patients. Suicide related phone calls increased by 19% in 2020. Their 50 year anniversary is this year and they hope to be able to celebrate this achievement by the end of 2021.

- Darryl Alexander, YUMADAOP hopes to be back in schools after spring break.
 YUMADAOP Coalition for Health Promotion (a drug free communities coalition) is currently working on their community needs assessment with SAMHSA
- Suzette Miller, Meridian Healthcare thanked Mark Dunlap for his help securing funds for uninsured clients. Four inpatient beds will be available March 9, 2021.
- Joe Shorokey, Alta The campus of Care is coming along well. They are waiting for their occupancy permits to come through. The headstart classrooms have been set up and students are almost ready to move in. Alta is running anti-stigma ads, billboard, and radio commercials. - Darla Gallagher, Meridian is working with Neil Kennedy Recovery Center to expand detox available in Mahoning County with 24/7 access. Meridian has been approved to be a Covid-19 vaccination site. They are working with Aaron Bishop to get vaccinations. They have also contracted to provide veterans housing at the Chalmers location.
- Carolyn Givens, Neil Kennedy Recovery Center thanked the Board for their help in securing capital funds for the project. Conference calls will be held with NKRC, OhioMHAS, and Duane Piccirilli.
